## General Membership

## Business Meeting Oct. 9th

I urge you to join me in thanking the 2010/2011 board members for all their hard work and dedication. It is no easy task to make decisions that reflect the wishes of the entire membership. Stepping down at this time are: Rita O'Boyle, President/Finance Committee; Jim Pinkham, Building Committee; Steve Bryson, Course Maintenance/ Greens Committee.

Please welcome those individuals who are taking their place; Sue Crockett, Jim Ghiglione, Gary Hall. Thank you for stepping up to the plate and taking on the role of Trustee. More on them later in this issue.

Of special note from the Committee Heads:

Dodie Schiessl reported that although our certificate members are down a bit this year, we gained a substantial number of junior members. It seems our efforts this year to promote junior golf have indeed worked.

Course Maintenance currently has a great workforce. All our machinery is in good condition as is the course itself. Although Steve Bryson is stepping down as Trustee, he will continue on in a supervisory role for the course management.

The Buildings Committee, reported by Jim Pinkham, has solved most of the pending issues. Larry Prewitt has completed the roofing of the main building and is currently working on solving the leak issue of the cart shed. The well continues to have its occasional problems and did fail its last test. However, Don Langrock is spearheading a solution and hopefully it will be back in compliance soon.

Finances. Ah yes, it is the biggest concern with small golf courses around the nation. These are tough times and the Lopez Island Golf Course is not immune. Here is where we spent most of our time that evening. How do we keep the "Course Standard" that was implemented several years ago, with the rising cost of so many pieces of the puzzle, ie: fuel, labor, supplies? Do we keep the "Course Standard" and raise dues....perhaps losing members because of the increase? Do we let the standard fall, not raise dues and perhaps lose members and guest greens fees because of a deteriorating course? We argued and we haggled and we contemplated solutions. The solution we came up with and one that passed commandingly was to minimally raise dues (after 3 years of no increase) by \$25 AND to implement a \$1.00 per round special fee to all members (starting in 2012), paid on the Honor System. Ok, I can hear you guys moaning through the airwaves :-). But hear me out ..... it was decided in this way those members who utilize the course more will pay more instead of having a higher Dues-to-All increase which may drive away members who play infrequently. It was roughly calculated for 2011 year to date, there were 3500 member rounds, whether 9 or 18 holes, which will bring the club the additional funds to balance the budget and keep the course standard high. I hope the entire membership will realize how hard it was to solve our financial dilemma and will give this solution a whole hearted try. Remember, nothing is cast in stone.....if this proves to be a 'White Elephant', we can always try something different next year. AND don't forget, the more certificate members we have, the easier it is to meet our financial obligations......so bring in those friends!
